The acquisition of the derivative securities was exempt from Section 16 of the Securities Exchange Act of 1934, as amended.
- (3) These incentive units will vest in three equal installments on each anniversary of December 22, 2021, subject to the director's continued service. Incentive units do not expire.
- (4) Vested common units are exchangeable, subject to certain restrictions in the Fourth Amended and Restated Operating Agreement of Focus LLC, for (i) an equal number of shares of the Issuer's Class A common stock or, (ii) at the election of the Issuer, cash. The acquisition of the derivative securities was exempt from Section 16 of the Securities Exchange Act of 1934, as amended.
- (5) These common units will vest in three equal installments on each anniversary of December 22, 2021, subject to the director's continued service.
